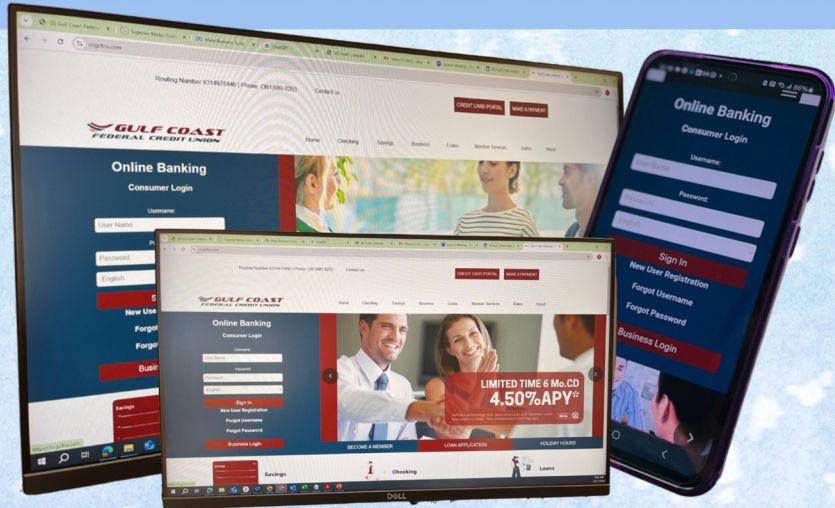

ATM SAFETY NOTICE



The following information is a list of safety precautions regarding the use of Automated Teller Machine (ATM) and Night Deposit Facilities:

- 1. Stay Alert:** Be aware of your surroundings, especially at night. Bring someone with you after dark if possible.
- 2. Keep Your Distance:** If someone is too close, ask them to step back before completing your transaction.
- 3. Secure Your Cash:** Avoid counting or displaying money at the ATM. Put away immediately and count it later in a safe location.
- 4. Act on Suspicion:** If you notice any unusual, cancel the transaction and leave. Use another ATM or return later.
- 5. Protect Your Pin:** Never write your PIN on your card or share it with anyone.
- 6. Report Issues:** Immediately report any suspicious activity or crimes to law enforcement.
